Monday, July 5, 2010

1615 An officer conducted a traffic stop in the 4500 block of Croftshire Drive. Tuesday, July 6, 2010

0154 An officer stopped Gary L. Welch (W/M/47), for weaving on Patterson at Woodman. He failed the FST and was arrested for OVI. While at Kettering Jail he refused the data master test.
