Tuesday, August 3, 2010

0003 An officer ran a registration in the area of 5387 Oakvista and found that there was an active warrant for Christopher C. Roberts (W/M/22). Roberts was placed under arrest for the FTC warrant without incident.

1602 An officer stopped a vehicle in the parking lot at 3201 Wilmington for a violation. Upon contacting the occupants, it was learned the passenger was wanted on an active Kettering warrant.
