POLICE BLOTTER

Monday, August 9, 2010

1543 An officer responded to Elder Beerman for a female shoplifter in custody. Upon arrival, it was learned that Ronda M. Holbrook, w/f/39, had shoplifted approximately \$363.00 in merchandise. She was also found to be wanted on an active warrant through Moraine P.D. Holbrook was placed under arrest for the warrant and transported to KPD jail. She was issued a summons for the theft offense. 10-37576

1917 An officer stopped a vehicle for improper registration at Dorothy and Rushland. The driver, Gary Buckner, w/m/46, was asked to exit the car for further investigation, and during this time dropped a bag of suspected heroin on the pavement.
