Monday, January 10, 2011

2035 Officers went to 1200 Eldorado to attempt a warrant service. Once there they identified the wanted person, Jacob L. Skeens, w/m, 21; who was wanted on a KMC bench warrant for FTC/Fines. He was transported to KPD Jail for booking. 10-34424
